Sub:- Application dated 27.04.2017 of the **Managing Trustee, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat** to establish a new Ayurveda Medical College in the name of “**Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat**” with 60 seats in UG (BAMS) course, under Section 13A of the IMCC Act, 1970 from the academic session 2019-20 – **Permission Letter -reg.**

Sir,

I am directed to refer to Ministry's order dated 26.06.2018, wherein Ministry had conveyed disapproval of application dated 27.04.2017 and denial Letter of Intent for starting new Ayurvedic Medical College from the academic session 2018-19 under section 13A of the IMCC Act.

2. Whereas, in compliance of order dated 03.08.2018 of Hon'ble High Court of Gujarat, another opportunity of hearing was granted on 14.08.2018. During the hearing it was found that the Trust could not produce sufficient documents/evidences to substantiate their claim of having required Minimum Standards to establish new Ayurveda College as mentioned in IMCC Act & relevant regulations. Hence, this Ministry once again with the approval of the Competent Authority, vide its letter dated 19.09.2018, conveyed to the Applicant Trust of the aforesaid college, the disapproval of their application dated 27.04.2017 and denial letter of intent for starting new Ayurvedic Medical College.

3. In compliance of order dated 17/12/2018, of Hon'ble High Court of Gujarat, in R/Special Civil Application No.16594 of 2018, the CCIM had visited the college on 01.01.2019 and recommended to the Central Government for not issuing Letter of Intent to you vide its letter No. 26-131/2017-Ay dated 17.05.2019, to establish a new Ayurveda college in the name of **"Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujapur, Patia, Sidhpur-384151, Distt. Patan, Gujarat"** with 60 seats in UG (BAMS) course from the academic session 2019-20 under section 13A of the IMCC Act, 1970.

4. In view of the deficiencies mentioned in CCIM visitation report, under provisions of the first proviso to sub-section (5) of section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 12.06.2019, vide Hearing Notice of even no. dated 03.06.2019. During hearing it was found that the Trust could not produce sufficient documents/evidences to substantiate their claim of having required Minimum Standards to establish new Ayurveda College as mentioned in IMCC Act & relevant regulations.

5. Therefore, Ministry of AYUSH, vide its letter dated 10.07.2019, conveyed to the Applicant Trust of the aforesaid college, the disapproval of their application dated 27.04.2017 and denial of Letter of Intent for starting new Ayurvedic Medical College.

6. In compliance of order dated 20.09.2019, of Hon'ble High Court of Gujarat at Ahmedabad, in R/Special Civil Application No.13394 of 2019, the CCIM had conducted an inspection of the college on 25-26.09.2019, and sent their visitation report to this Ministry vide its letter No. 26-131/2019-Ay dated 01.10.2019, to establish a new Ayurveda college from the academic session 2019-20 under section 13A of the IMCC Act, 1970. On examining the same, certain deficiencies were observed. Hence, the college was given an opportunity of hearing to present their case on 07.10.2019, and it is found that the college is fulfilling notified and approved criterion as per Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made there-under and as per approved Standard Operative Procedures (SOPs), for issuing **Letter of Permission** for conducting 60 seats in UG (BAMS) course from the academic session 2019-20.

7. It has, therefore, been decided by the Central Government to **issue Letter of Permission to Managing Trustee, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujapur, Patia, Sidhpur-384151, Distt. Patan, Gujarat** to establish a new Ayurveda Medical College in the name of **"Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujapur, Patia, Sidhpur-384151, Distt. Patan, Gujarat"** with 60 seats in UG (BAMS) course from the academic session 2019-20 under section 13A of the IMCC Act, 1970, subject to following conditions:

- i. The college shall submit an undertaking in form of affidavit duly notarized within one month from the date of issue of the letter, explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.



- ii. The colleges shall submit undertaking in the form of Affidavit duly notarized to get permanent registration of the Teachers/Hospital Clinical Staff/Consultant in concerned State Boards/Council where the college/hospital is located or Central Registration of the CCIM by 31st December, 2019 as per the decisions conveyed vide letters 22.03.2019 & 22.04.2019 by CCIM and decided by the High Court of Delhi in W.P. No. 2369 of 2019, which will be verified by the Council during next visitation while considering the matter for grant/denial of permission for the academic year 2020-21.
8. It is further informed that 15% of undergraduate seats of the permitted intake capacity of 60 UG seats shall be treated as all India quota. The counseling for seats under all India quotas shall be conducted by the Central Government and counseling for the remaining 85% seats shall be conducted by the concerned Counseling Authority of that State. If any seats are not filled up in the Central Counseling, the same shall be transferred to the said Counseling Authority to admit students as per their rules/ reservation policies/norms. **The permission of the college stands withdrawn if the college fails to comply with the Central counseling for all India quota or the students admitted thereunder.**
9. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.
10. Discrepancies, if any, may be immediately brought to the notice of CCIM and the Central Government.
11. The following requirements should be fulfilled by the college by 31st December, 2019 to get permission for the session 2020-21:
- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda); and
 - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*
12. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM Regulations, are in position before the admission of the first batch of students in the 1st professional of BAMS course is made, under intimation to the Central Government and CCIM.
13. The college has to develop the requisite infrastructure for IInd, IIIrd and IVth professionals well in time as per the CCIM norms which will be verified and reported by the CCIM at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
14. The college administration may take up the matter for recognition of the qualification under section 14(2) of the IMCC Act, 1970 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.

15. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2020-21.
16. Ministry's order of even number, **dated 10.07.2019**, stands withdrawn.
17. This issues with the approval of competent authority.
