Subject:- Grant of conditional permission to Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat (Inst. ID. AYU0533) with 60 seats under section 28 of the NCISM Act, 2020 for the academic session 2023-24 and relevant regulations thereunder in respect of appeal dated 12.09.2023-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

1. This is with reference to your first appeal filed by the **Principal of Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat (Inst. ID. AYU0533) vide letter ref no. GAC/ADM/appeal/716/2023 dated 12.09.2023** to the commission in respect of conditional permission with seat reduction issued to **Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat (Inst. ID. AYU0533) with 54 seats (instead of 60 seats)** due to not fulfilling the basic eligibility criteria in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", and provisions under the NCISM Act, 2020 and relevant regulations thereunder and other shortcoming as mentioned in seat reduction permission letter dated **06.09.2023**.
2. Thereafter the said appeal was placed before the Chairman, NCISM and Chairman NCISM constituted a Hearing Committee to provide an opportunity of hearing to the college. Accordingly, the letter was sent to **The Principal, Gokul Ayurvedic College, Gokul Foundation, Opp. I.O.C. Depot, State Highway No. 41, Sujanpur, Patia, Sidhpur-384151, Distt. Patan, Gujarat (Inst. ID. AYU0533) vide Commission's letter ref. No. NCISM/Comm./OPT Appeal/(2023-24)-(Gujarat) dated 27.09.2023** to appear before the designated hearing committee as constituted by the Chairman, NCISM on **28.09.2023** in respect of appeal filed under section 10(1)(g) and section 24(3) of the National Commission for Indian System of Medicine ACT, 2020 and to produce all relevant valid documents/records/ proof to substantiate the claims and make written submission and submit an authenticated copy of evidence/verifications to commission with shortcoming wise clarifications mentioned in the seat reduction permission letter dated 06.09.2023 passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM. The proceedings of appeal were held virtually on **28.09.2023 at 12.00 Noon** and on behalf of the college, **Dr. Sunil Joshi, Principal, Gokul Ayurvedic College, Sidhpur-384151, Distt. Patan, Gujarat** attended the hearing.
3. The hearing committee sought clarification from the **Principal, Gokul Ayurvedic College, Distt. Patan, Gujarat** regarding shortcomings mentioned in the letter dated 06.09.2023 passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM, which is as under:-
